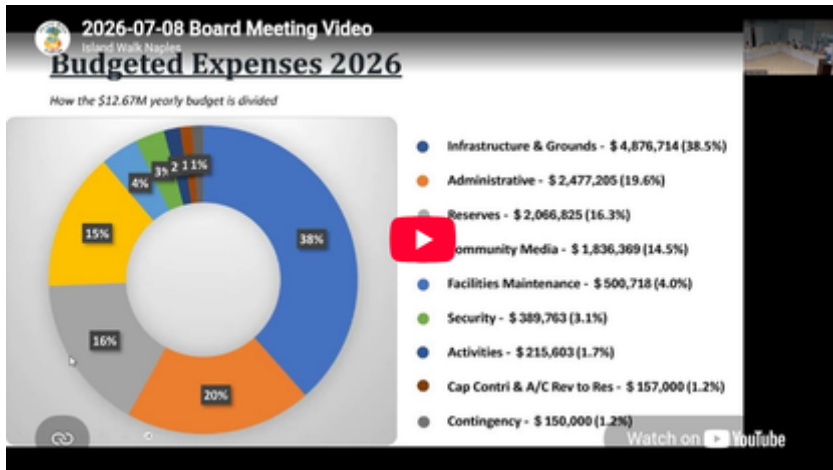

FRAUD WARNING!



FRAUD WARNING! CCSO wants everyone to be aware of a nationwide scam targeting senior citizens. Fraudsters tell victims they are in debt or their bank accounts are compromised. These scammers say you must pay in gold or large sums of cash, then send a courier to meet up to retrieve the money. In some cases they want you to withdraw cash, convert it to gold and then invest it in the Federal Reserve.

If anyone asks you for money, hang up and look up the organization's actual phone number and call it to confirm. Never provide your banking or credit card information without independently verifying who's asking for it and why.

For assistance with any suspected fraud, contact the Collier County Sheriff's Office's Call Before You Pay hotline – 239-252-CALL (2255). The hotline is staffed by a CCSO deputy in the Financial Crimes Bureau between 8 a.m. and 4 p.m. Monday through Friday. Outside of those hours you can call our non-emergency number at 239-252-9300.

FRUIT TREES ARE PROHIBITED

Please review Island Walk rules and regulations.

According to Island Walk Rules and Regulations, fruit trees are prohibited throughout the community.

POOL OR AC EQUIPMENTS MUST BE SCREENED WITH SHRUBS

All equipment must be screened from the street view, the lake view (if the property is adjacent to a lake or lake pathway), and from any neighbor's view to fully conceal the equipment at the time of installation. Screening must utilize ACC-approved 15-gallon shrubs and planting material for landscape screening, 3 plants on each visible side.

Landscape screen height must match or exceed the height of the equipment. The owner is responsible for maintaining such screening while the equipment is in place: Equipment Hedging

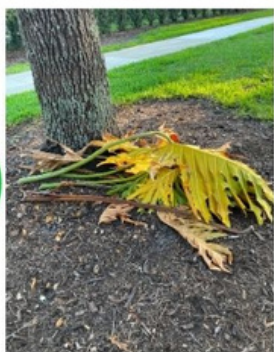

Upto **2 armfuls of vegetative debris** may be placed curbside in front of your home on the corner of the driveway or on the mulched area of the oak tree ring the evening before or by 7 am on the designated pick up day.

Please be respectful of your neighbors and store debris out of view until the designated day. Debris left out other than on the pick up day is in violation of Island Walk rules.

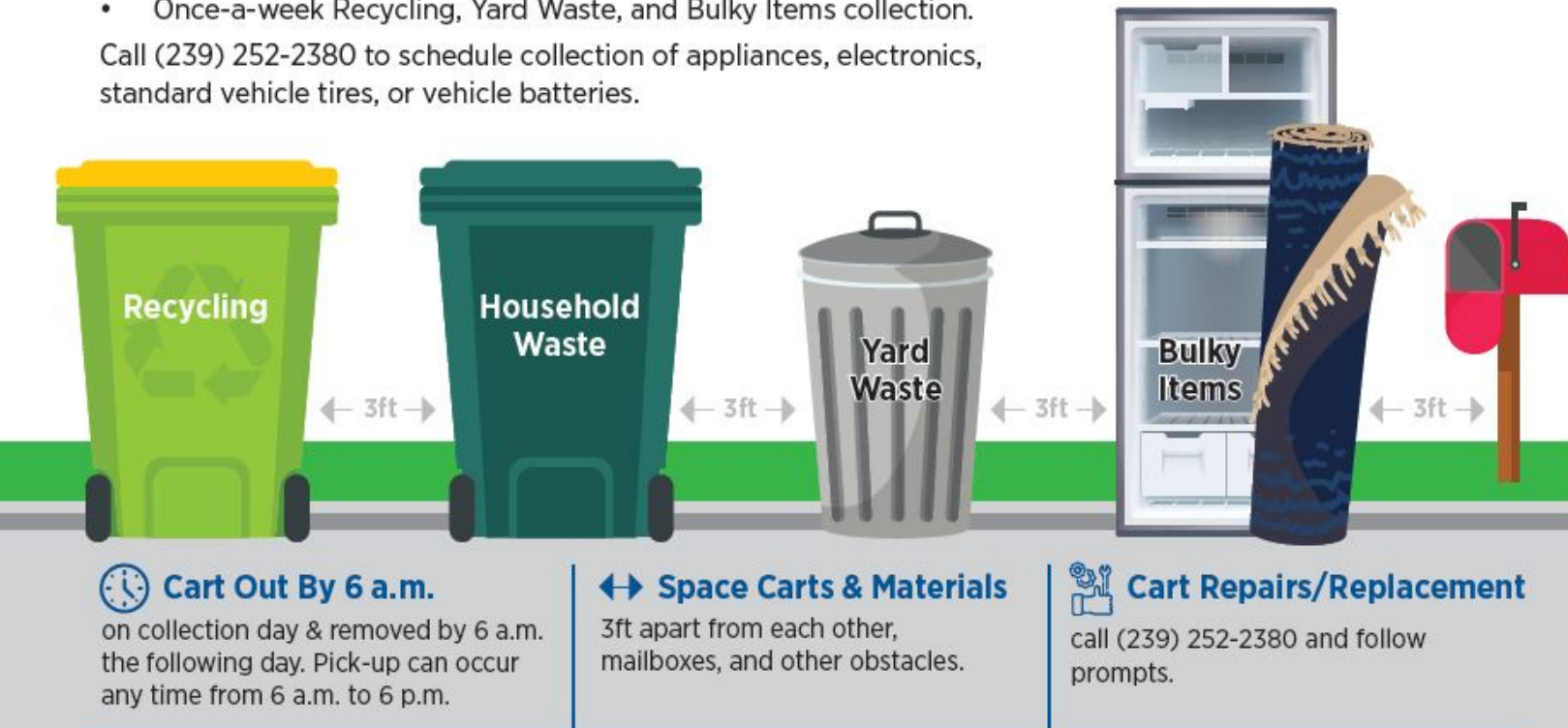
On Wednesdays Collier County will pick up debris in paper yard waste bags (NO PLASTIC), in personal bins (up to 45 gal), or tied with twine in bundles no longer than 4 ft.

Residential Curbside Collection

Services Include:

- Twice-a-week Household Waste curbside collection.
- Once-a-week Recycling, Yard Waste, and Bulky Items collection.

Call (239) 252-2380 to schedule collection of appliances, electronics, standard vehicle tires, or vehicle batteries.



There will be **no curbside services** on Fourth of July, Thanksgiving Day, or Christmas Day.

There are **no make-up days**. If your collection falls on one of these holidays, your trash, recycling, bulky items and yard waste will be collected on your next scheduled day.
